Entries will close when this limit is reached if this occurs prior to the specified closing time. Entries accompanying the last entry may be accepted. No more than 50% of the entries in any one stake may be handled by the same handler.**

## Driving Directions

Spero Manson Ranch, Maul Road & CR102  
**Grounds: 39°14'12.18"N, 104°26'11.71"W**

**From Franktown, CO:** Take State Hwy 86 east through Kioto Maul Road (20 miles).

**From Kiowa, CO:** Take State Hwy 86 east to Maul Road (4 miles).

Go south (right) on Maul Road 6.5 miles until it ends at County Road 102.

**From Elbert, CO:** Go East on CR 98 (1 mile), Go north (left) on CR 33/CR 102 (5 miles to Maul Road.

The grounds will be through the gate on the south side of the intersection.
