Amateur Gun Dog (RET) is a Call Back to Retrieve. Bring your BLAZE ORANGE. Bobwhite quail, and/or chukars, and/or pheasants released in all stakes except open puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes. Shotguns with blank shells will not be permitted.
