- This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant.
- The Amateur Gun Dog, Amateur Walking Gun Dog, and Open Gun Dog stakes are open to Vizslas only. All other stakes are open to all AKC registered Pointing Breeds.
- Horseback handling will be permitted in all stakes except AWGD.
- Stakes are limited to a maximum of 16 entries, except for Open Derby which is limited to 8 entries and OLGD which is limited to 18.
- In the event a stake has exceeded its limit before or on 8/18 (the open date), then those entries received before 8/18 and those entries received on 8/18 will be drawn randomly to determine which entries are accepted into the stake.
- Bitches in season are eligible for entry in AWGD, OD, and OLGD. The FT Secretary must be notified the bitch has come into season at least one-half hour prior to the beginning of the stake which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.
- Shotguns with blank shells will not be permitted.
- AKC approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.

- Quail, Chucker and/or Pheasant will be released in all stakes.

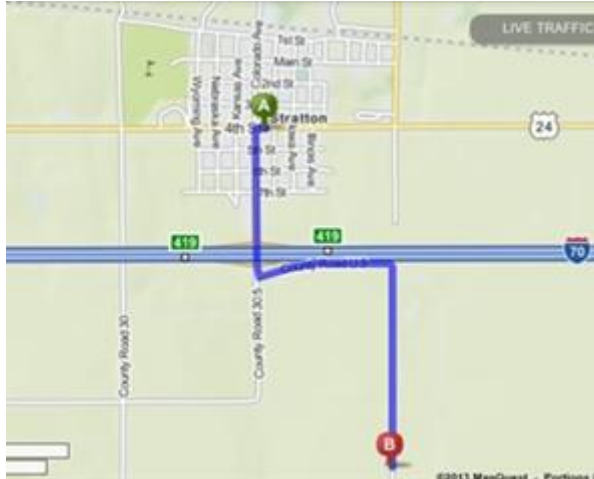
