- This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant.
- Horseback Handling will be permitted in all stakes.
- Bitches in season are eligible for entry in OLGD. The FT Secretary must be notified the bitch has come into season at least one-half hour prior to the beginning of the stake which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.

- Shotguns with blank shells will not be permitted.
- AKC approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.

### **STAKE LIMITS**

All stakes open to all AKC registrable pointing breeds. No more than 50% of the entries in any one stake may be handled by the same handler. AGD, OGD, and OLGD stakes are limited to 14 dogs each. Open Puppy and Open Derby stakes do not have limits other than daylight hours as these stakes combine with the limited stakes.

Additional entries may be accommodated in limited stakes if stake limits are not filled in any limited stake or if daylight hours limits are not reached with juvenile entries.

### **COURSES AND BIRDS**

- Courses without bird field. No birds in puppy stakes
- Derby Stakes 20 minutes. Puppy Stakes 15 minutes
- Gun Dog Stakes 30 minutes. Call backs for retrieving stakes
- Quail, Chucker and/or Pheasant will be released in all stakes.

### **PRIZES**

- Rosettes will be rewarded to all placing dogs in each stake.

### **TRIAL GROUNDS AND FACILITIES**

- All participants are required to complete a Release of Liability and Waiver.
- RV camping/horse trailer parking is available. Electrical hook ups may be available at \$15 per night.
- There will be hydrants on site to fill tubs with water.
- Dogs are not permitted to be off leash except during the running of their brace. Please clean up after your dogs.
- The Rocky Mountain Vizsla Club, any of its members, or the owners of Six Shot will not be held liable for any damage or injury to participants, their horses, dogs, vehicles, trailers and any other personal equipment.

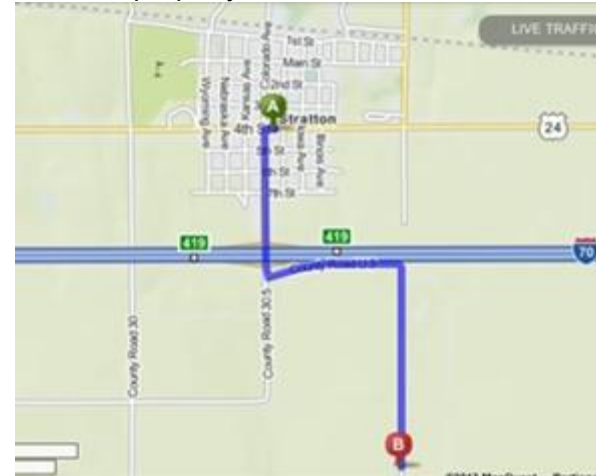
