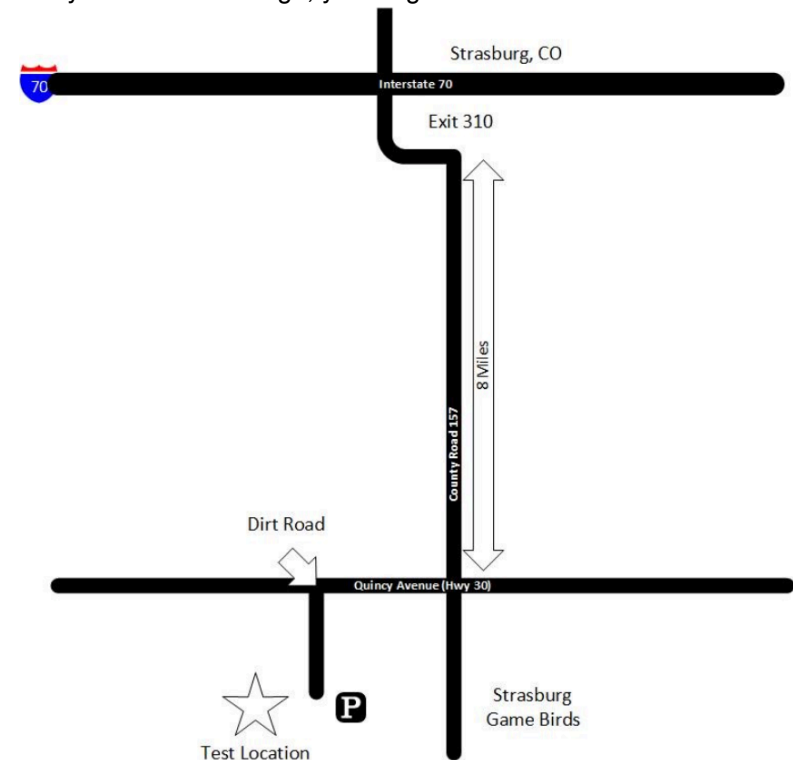
## COURSES AND BIRDS

Senior and Master Hunt Tests will run 30 minutes. Junior Hunt Test will run 15 minutes. Tests will run on a single course with bird field.

Quail and/or Chukar and/or pheasants will be released in all stakes. Judges and officials only are allowed to use horses. Shotguns with NO ammunition will be permitted to be carried by handlers of Master dogs only. Participants must wear blaze orange on all courses. Galleries are permitted only at the discretion of the hunt test committee and judges when safety permits, are under the control of the marshal, and not permitted in any bird field.

## DIRECTIONS TO GROUNDS

Strasburg Game Birds - 5220 S County Rd 157, Strasburg, CO 80136  
Take I-70 to Exit 310. Turn south and take an immediate left along the I-70 Frontage Road, which becomes CR 157. Proceed south approximately 8 miles to Quincy Ave. (HWY 30), turn right on Quincy Ave. Turn left to get to the hunt test grounds. If you cross the bridge, you've gone too far.
