This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant.

- The Amateur Derby is open to *Vizslas only*. All other stakes are open to all AKC registerable Pointing Breeds.
- Bitches in season are eligible for entry in OD and AD. The FT Secretary must be notified the bitch has come into season at least one-half hour prior to the beginning of the stake in which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.
- Entry Fees include a \$3.00 Processing Fee. Entries may be cancelled or changed online prior to close of entry, with refunds (less a Processing Fee of \$3 per entry and \$1 per food or camping item) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries and food/camping items may be cancelled online after close of entry, but no refunds will be given. STAKE LIMITS

All stakes are open to all AKC registrable pointing breeds (except for posted "Vizslas only"). No more than 50% of the entries in any one stake may be handled by the same handler. AGD, OGD, ALGD, and OLGD stakes are limited to 14 dogs each. Amateur Derby, Open Puppy and Open Derby stakes do not have limits other than daylight hours as these stakes combine with the limited stakes. Additional entries may be accommodated in limited stakes if stake limits are not filled in any limited stake or if daylight hours limits are not reached with juvenile entries.

COURSES AND BIRDS

- Course without bird field for all stakes.
- All stakes are walking, horseback handling will not be permitted in any stake.
- Puppy Stakes 15 minutes. Birds *will not* be released.
- Derby Stakes 20 minutes.
- Gun Dog Stakes 30 minutes.
- AGD, ALGD, and OLGD stake will have callbacks for retrieving.
- Quail, Chukar and/or Pheasant will be released in all stakes.
- Shotguns with blank shells will not be permitted.
- AKC Approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.

PRIZES

- Rosettes will be awarded to all placing dogs in each stake.
- The "Cowboy's Dream" traveling trophy will be awarded to the winner of the Amateur Derby stake. This is a beautiful limited edition Dannyquest sculpture. This trophy will be enjoyed by winners for many years to come.

Go North into town on Colorado Ave. for ½ mile

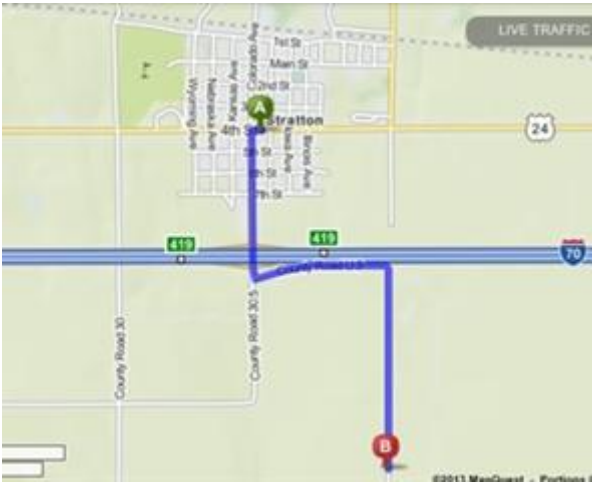
Turn Left (West) on 4th Street (Hwy 24) for ½ mile.
