This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant.

- Horseback handling/walking will be permitted in all stakes.
- Bitches in season are eligible for entry in OP and OGD. The FT Secretary must be notified the bitch has come into season at least one-half hour prior to the beginning of the stake in which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.
- Shotguns with blank shells will not be permitted.
- AKC approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.
- Entry Fees shown include a \$3.00 Processing Fee. Entries may be cancelled or changed online prior to close of entry, with refunds (less a Processing Fee of \$3 per entry and \$1 per camping item) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee).
