This trial is being run under the flexible format option. The field trial committee reserves the right to rearrange the running order should conditions warrant.

Bitches in season are eligible for entry in OD and AGD. The FT Secretary must be notified that the bitch has come into season at least one-half hour prior to the beginning of the stake in which the bitch is entered. The running order will be modified so that the bitch(es) in season will run in the last brace(es) for that day.

Entry Fees include a \$3 Processing Fee for all juvenile stakes and \$4 for gun dog stakes. Entries may be cancelled or changed online prior to close of entry, with refunds (less a Processing Fee of \$3 per juvenile entry or \$4 per gun dog entry) available to keep as PerfDog credit, refund to credit card, or mail via check (less a \$3 Check Fee). Entries may be cancelled online after close of entry, but no refunds will be given. ### **STAKE LIMITS**

All stakes are open to all AKC registrable pointing breeds. No more than 50% of the entries in any one stake may be handled by the same handler. Entries are limited to daylight hours.

### **COURSES AND BIRDS**

- Course without bird field for all stakes.
- All stakes are walking, horseback handling will not be permitted in any stake.
- Puppy Stakes 15 minutes. Birds *will not* be released.
- Derby Stakes 20 minutes.
- Gun Dog Stakes 30 minutes.
- ALGD, OLGD, and AGD stakes will have callbacks for retrieving.
- Quail, Chukar and/or Pheasant will be released in all but puppy stakes.
- Shotguns with blank shells will not be permitted.
- AKC Approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.

Rosettes will be awarded to all placing dogs in each stake.

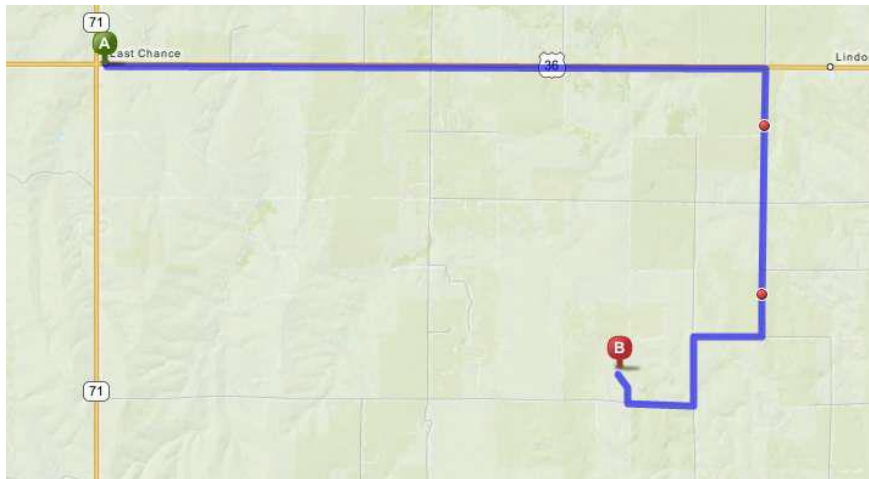

From Highway 36 and 71 (Last Chance, CO)  
Go East, 9.7 miles, toward Lindon, CO.  
Go right (South) on County Road S for 4 miles. (First right hand turn after getting into Lindon)  
Go right (West) on Road 8 for 1 mile.  
Go left (South) on Road R for 1 mile.  
Go right (West) on Road 7 for 1 mile.  
Go right (North) on Road Q for ½ mile.  
Road Q (is poorly marked and looks like a farm road), It is the entrance to the hunt test area (Ohr Ranch).  
There are many roads that you can take to the grounds, but for trailers, this is the recommended route.
