Bobwhite quail will be released in all stakes except Open and Amt. Puppy. A blank cartridge will not be fired in the puppy stakes. **Horseback handling will not be permitted in any stake.** Shotguns with blank shells will not be permitted.

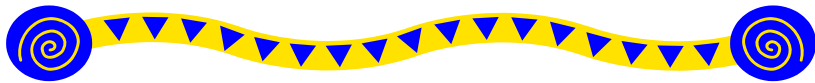
