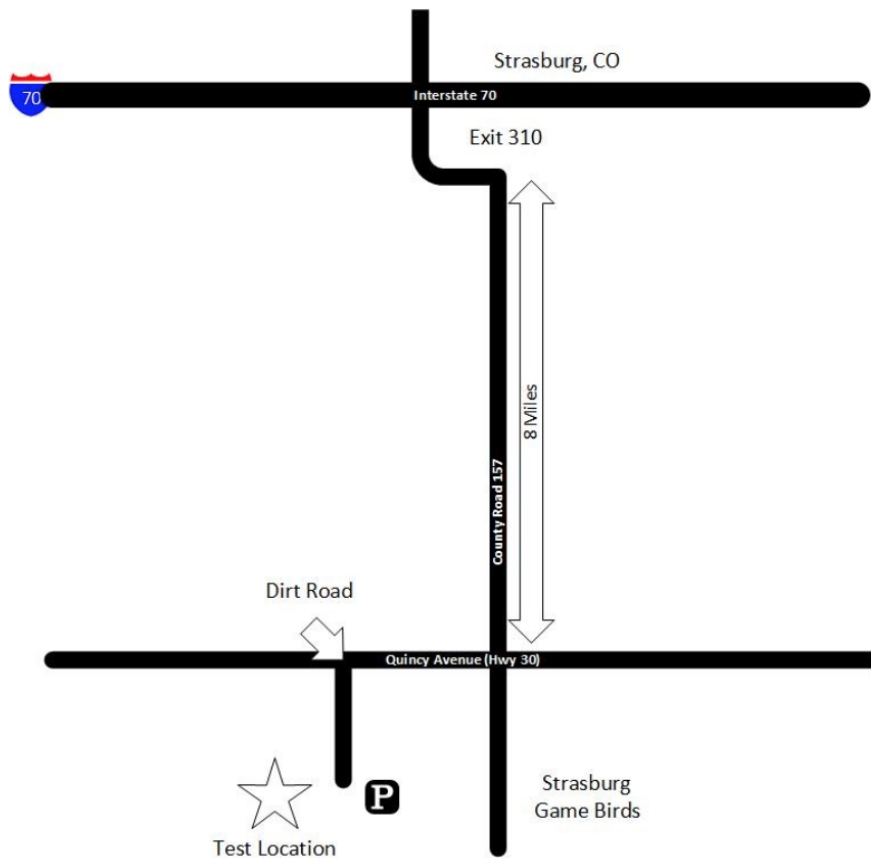

Take I-70 to Exit 310. Turn south and take an immediate left along the I-70 Frontage Road, which becomes CR 157. Proceed south approximately 8 miles to Quincy Ave. (HWY 30), turn right on Quincy Ave. Turn left to get to the hunt test grounds.

All participants are required to complete a Release of Liability and Waiver to Strasburg Game Birds. Releases will be at the grounds and you must sign prior to running your dog!

Please bring water for yourself and your dogs. Overnight camping is allowed for \$10.00/night but there are no camper hookups. Please be sure to fill any holes and leave no trash behind.

There will be no training of dogs on the grounds at any time during the course of these events.

Participants must wear blaze orange on all courses.
