### Courses

### Running Dogs in Congruent Tests

AKC policy now allows dogs to run congruent in all levels. Dogs can now obtain legs/passes in different levels and work on earning titles at the same time. Example: A dog can run in Senior and Master levels in the same event and earn passes that will count toward the required pass total for each level. With regard to the number of passes needed, all other AKC requirements apply.

### Advanced Titles

AKC now has Advanced titles (JHA, SHA, and MHA). A Pointing Breed Hunting Test Advanced title is awarded when a dog passes five additional times with an average qualifying score of 8.0 or higher after earning its initial title in a test level. 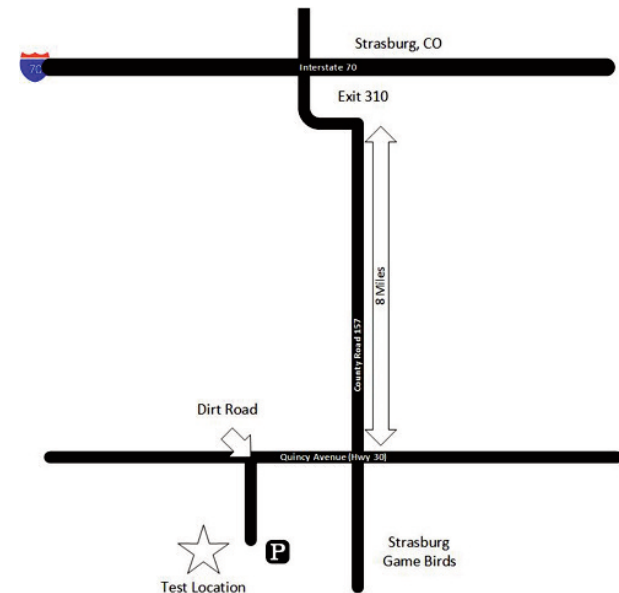

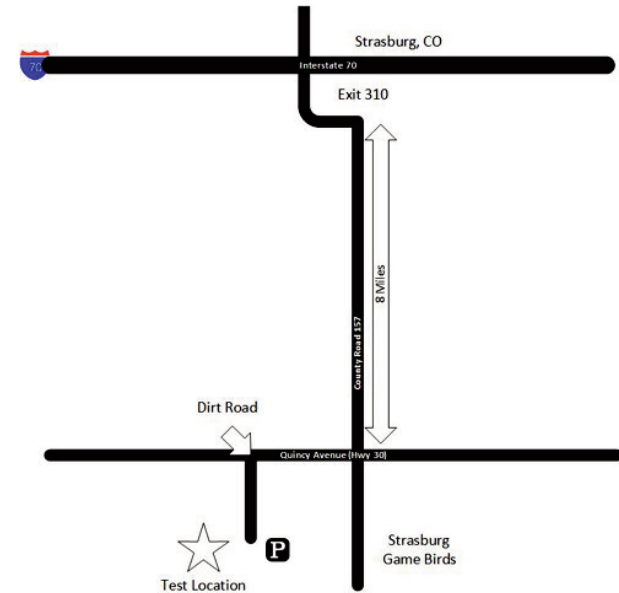
