Amateur Gun Dog is shoot on course. **ORANGE VESTS** are required for all participants in Amateur Gun Dog. Bobwhite quail, and/or chukars, and/or pheasants released in all stakes except open puppy. A blank cartridge will not be fired in the puppy stake. Horseback handling will be permitted in all stakes. Shotguns with blank shells will not be permitted.
