**The field trial committee reserves the right to rearrange the running order should conditions warrant.**

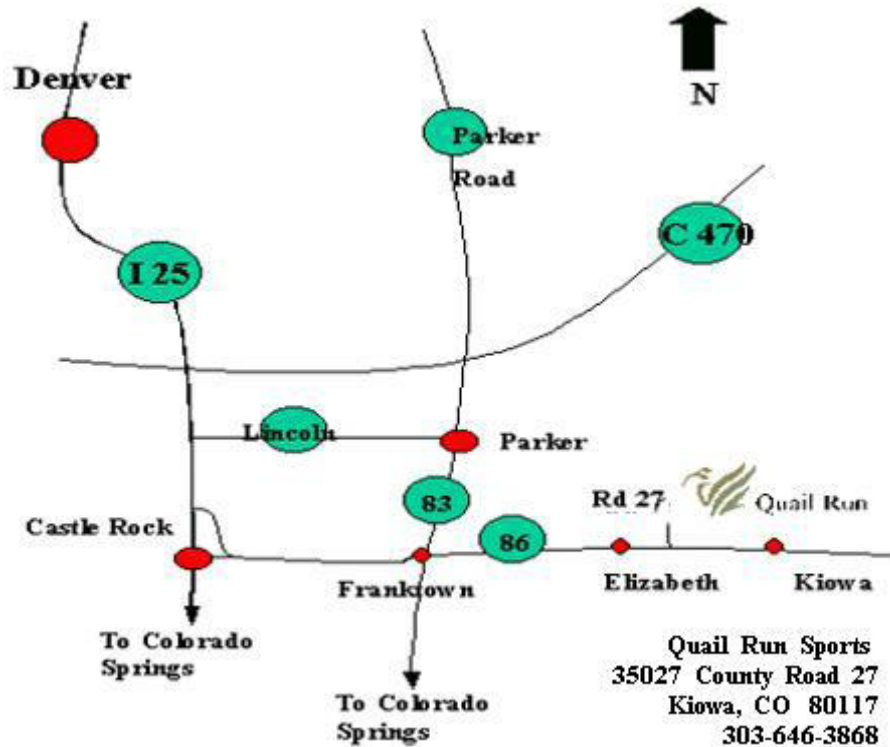
All stakes are open to all AKC registerable Pointing Breeds 6 months of age or over. Bitches in season are not eligible for entry in any stake.

## COURSES AND BIRDS

Single course without birdfield for all stakes. Open Puppy 15 minutes, birds released. A blank cartridge will not be fired in the puppy stake. Open Derby 20 minutes. Open Gun Dog 30 minutes. Quail, Chucker and/or Pheasant will be released in all stakes. Judges and officials only are allowed to use horses. Shotguns with blank shells will not be permitted. AKC Approved tracking collars may be used in all stakes per AKC regulations. A list of approved models are listed at: <http://www.akc.org/trackingdevices/>.

## DIRECTIONS TO TRIAL GROUNDS:



This event will be held at Quail Run Sports, just a couple of miles east of Elizabeth. From Denver, take I-25 towards Colorado Springs. Exit onto W/E- 470 TOLLWAY exit number 194 toward Grand Jct. Take the E-470 TOLLWAY exit to the left. Merge onto E-470. Merge onto CO-83 via exit number 5. Turn left onto CO-86. Turn left onto CR-27.

Watch for the Field Event signs and orange streamers.
