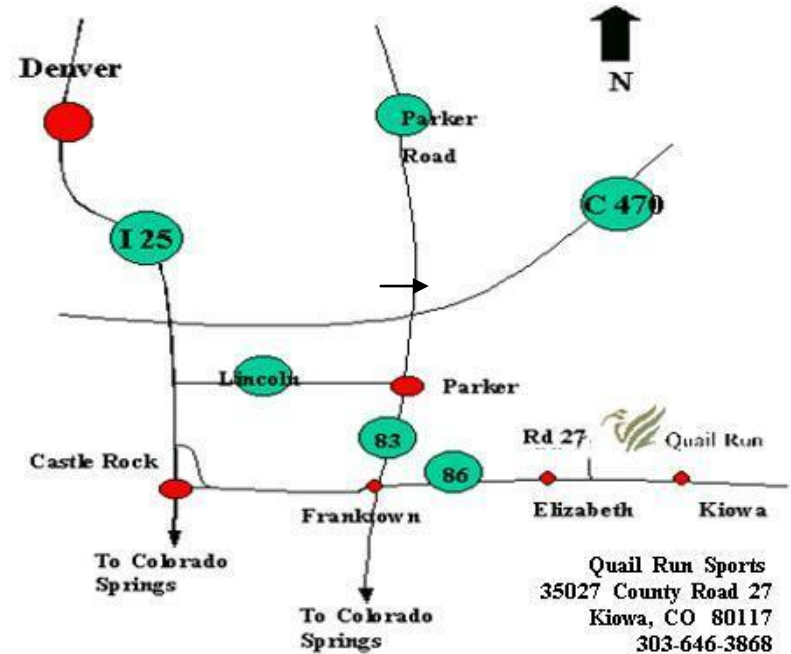

ACKNOWLEDGMENT OF ASSUMPTION OF THE RISK OF INJURY OR
DEATH**

READ THIS ENTIRE AGREEMENT CAREFULLY (4-2-09)

The undersigned, _____, (PLEASE PRINT NAME) has (1) agreed to allow Quail Run LLC to accompany or lead me on a hunting, fishing, hiking, and/or camping trip; and/or, (2) requested permission from Quail Run LLC to enter upon or use certain land and waters for the purpose of hunting, fishing, hiking and/or camping and all shooting activities. I acknowledge that all of the above, entry upon and use of such land for such purposes present risks of injury or death to any individual involved. Among these risks are the following:

1. Injury or death as a result of both obvious and hidden conditions and dangers of the land and waters upon which I may enter, travel upon or use (including, but not limited to, drowning, falling, slipping, getting caught in traps, or being struck by falling branches, rocks or other objects);
2. Injury, but not limited to, sunburn, sun poisoning, dehydration, exposure, and hypothermia or death due to the acts or omissions of other persons (such as hunters, fishermen, campers and hikers) both within my party, and those not associated with my party (including, but not limited to, being shot or being assaulted by such person);
3. Injury or death as a result of contact or encounters with animals, insects, the elements (including) food, poisoning, poisonous plants and dangerous waters and floods;
4. Injury or death as a result of my own health conditions, such as exhaustion, heart attack and stroke due to physical exertion or fright; and or both.
5. All other risks inherent in or attendant to hiking, camping, fishing, hunting, tracking animals and traveling in the out of doors.

I understand that the above is not an exclusive list of all risks of injury or death I may be exposed to, or activities I may engage in during the time period 4-16-11 until 4-18-11 I also understand that some of the risks of injury or death may result from someone's failure to warn me of a specific risk.

I EXPRESSLY ASSUME ALL SUCH RISKS AND WAIVE ANY CLAIMS I MAY HAVE AS A RESULT OF INJURY OR DEATH ARISING FROM THE ACTIVITIES DESCRIBED ABOVE AGAINST QUAIL RUN ANY OF QUAIL RUN AGENTS, EMPLOYEES, PARTNERS, CO-VENTURERS OR CO-OWNERS, AS WELL AS ANY OWNER, TENANT OR ANY OTHER PERSON WITH AN INTEREST IN ANY LAND OR WATER THROUGH OR UPON WHICH I MAY TRAVEL, AS PART OF ACTIVITIES ORGANIZED BY QUAIL RUN LLC.

Except to the extent such claim might be based upon the sole and exclusive negligence, or intentional misconduct, of Quail Run, or any of its agents, employees, tenants, co-venturers, partners or co-owners, I further agree to hold Quail Run and its agents, employees, partners, co-venturers, tenants and co-owners harmless for physical injury to others, or for property damage, which results from my participation in any of these activities, and to indemnify these persons against all loss and expense arising from my participation in these activities.

This agreement shall be effective and binding upon me from the date I sign this forward.

I ACKNOWLEDGE HAVING READ AND UNDERSTOOD THIS AGREEMENT, THAT I AM ENTERING INTO THE AGREEMENT OF MY OWN FREE WILL, AND THAT I HAVE BEEN AFFORDED AN OPPORTUNITY TO SEEK AN EXPLANATION OF THE RAMIFICATIONS AND EFFECT OF THIS AGREEMENT FROM OTHERS OF MY OWN CHOOSING.

THE CLAIMS I AM RELEASING AS A RESULT OF SIGNING THIS AGREEMENT INCLUDE BUT ARE NOT LIMITED TO NEGLIGENCE, ANY WRONGFUL OR TORTIOUS ACT OR OMISSION, ANY BREACH OF EXPRESS OR IMPLIED WARRANTY, ANY INNOCENT OR NEGLIGENT MISREPRESENTATION, AND ANY RECKLESS ACT OR OMISSION.

I further warrant and represent that I am experienced in the out of doors and associated hunting, fishing, camping and hiking activities; that I am over the age of eighteen (18); and, that I understand that Quail Run is relying on these representations.

In the event any suit or claim brought by me or on my behalf against Quail Run (or any of its agents, employees, tenants, co-venturers, partners or co-owners), I agree to pay reasonable attorney's fees and expenses incurred by any of them in defense of said suit or claim, except if Quail Run (or any of its agents, employees, tenants, co-venturers, partners or co-owners) is/are the party(ies) determined to be responsible for the injury or damage claimed, or in the event such suit or claim is found to be barred due to the terms of this agreement.

This agreement is binding upon my successors, assignees and legal representatives. This agreement shall be interpreted in accordance with the laws of the State of Colorado. Any suit or claim arising out of this agreement, or the activities which are the subject of this agreement, shall be brought in the appropriate court. The invalidity of any part of this agreement shall not affect the validity of any other part.
