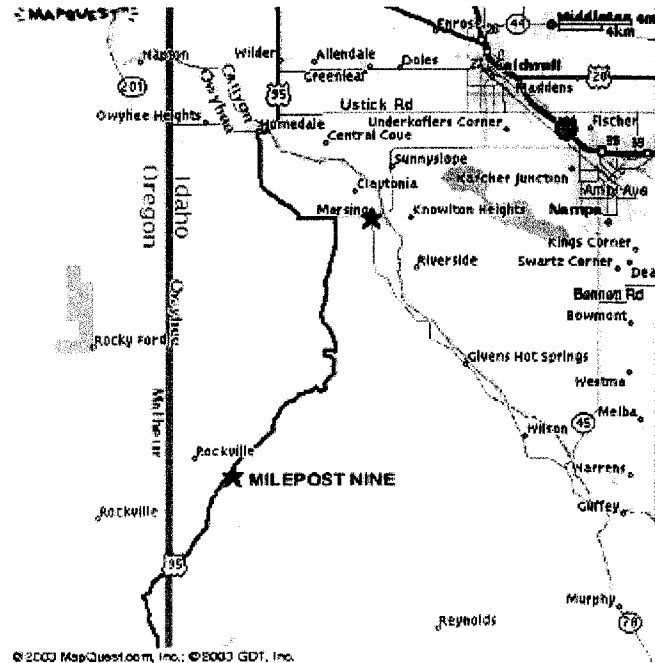

A blank cartridge will be fired in open puppy and open derby. Horseback handling will be permitted in all stakes. Shotgun blanks not permitted.

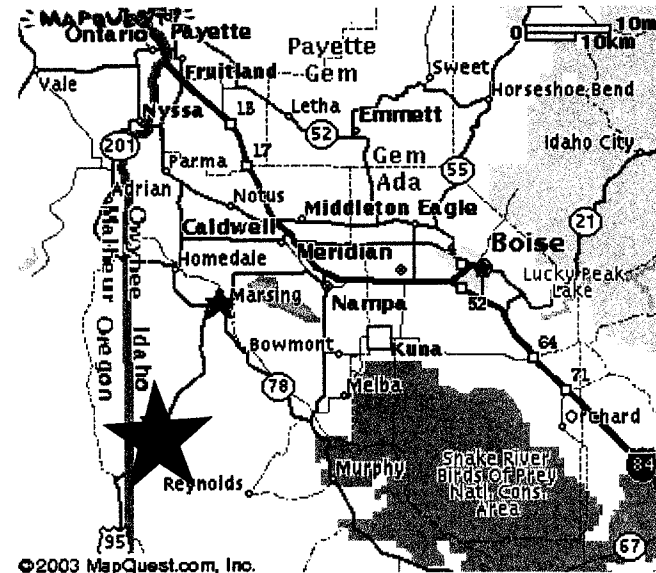
